4. Lower Ness INNS Project

Work is continuing and JK has almost been eradicated from the Enrick and Coiltie. However complete eradication is probably impossible due to the difficulty in finding those last few plants. Work continuing up in Inverness. There is no funding for next year and this perennial problem isn't getting better and doesn't fit in with the national initiatives to control INNS. Lots of policy, no delivery mechanism. This problem probably needs to be addressed with a separate fund to bid into for the control of INNS.

7. Giant Hogweed

Work continuing on all known infestations. Some issues with certain landowners seeming not to spray this year, but only in one isolated spot. Himalayan Balsam starting to spread into the Auldearn Burn after removal of the GH, so further work required there.
